1. Tax Credit Legislation

Council Bill 5-2018 - Introduced by: Calvin Ball - AN ACT establishing a tax credit against the County property tax imposed on residential real property that is owned by specified public safety personnel; establishing the amount, terms, conditions, and duration of the credit; providing for an application and verification procedure and administration of the credit; and generally relating to property tax credits. *(Expires 3/8/18; 4/7/18 if extended; or 5/7/18 if extended twice.)*

Council Bill 7-2018 - Introduced by: The Chairperson at the request of the County Executive - AN ACT establishing a tax credit against the County property tax imposed on certain real property that is owned by certain public safety officers under certain circumstances; establishing the amount, terms, and conditions of the credit; and generally relating to real property tax credits. *(Expires 3/8/18; 4/7/18 if extended; or 5/7/18 if extended twice.)*

2. APFO-related Legislation

Council Bill 1-2018 – Introduced by: Calvin Ball, Jennifer Terrasa, and Jon Weinstein -AN ACT amending the Adequate Public Facilities Act requiring certain periodic review; specifying completion timelines for certain types of road remediation projects; requiring that certain agreements contain certain provisions with regard to the timing of road mitigation projects; amend the title of certain charts and other terminology; requiring certain waiting periods; clarifying certain exemptions; defining certain terms; amending certain definitions; making certain technical corrections; and generally relating to the Adequate Public Facilities Act of Howard County. *(Expires 3/8/18; 4/7/18 if extended; or 5/7/18 if extended twice.)*

Council Bill 2-2018 - Introduced by: Calvin Ball, Jennifer Terrasa, and Jon Weinstein - AN ACT amending PlanHoward 2030, the general plan for Howard County, to reduce the number of allocations in the Growth and Revitalization category and to increase the number of allocations in the Established Communities category, beginning in 2020; and generally relating to planning, zoning and land use in Howard County. (*Expires 3/8/18; 4/7/18 if extended; or 5/7/18 if extended twice.*)
