FINAL CONSIDERATION

General

Council Bill 43-2021 - AN ACT making emergency appropriations pursuant to Section 610(b) of the Howard County Charter and amending the Annual Budget and Appropriation for Fiscal Year 2021 in order to receive additional grant funding from the United States Department of the Treasury to provide rent and utility assistance; from the United States Department of Housing and Urban Development as part of the HOME Grant; from the Federal Emergency Management Agency's Public Assistance Program and the U.S. Department of Health and Human Services through the Howard County Health Department to provide funding to the County for costs associated with staffing community vaccination clinics led and funded by the Howard County Health Department and to fund the County's Mobile Integrated Community Health Program; and the first half of the Coronavirus State and Local Fiscal Recover Funds from the American Rescue Plan from through the United States Department of the Treasury, and declaring that this Act is an Emergency Bill necessary to meet a public emergency affecting life, health or property. *(Expires 8/16/21; 9/20/21 if extended; or 10/25/21 if extended twice.)*
