Council Bill 32-2013 - AN ACT Adopting the 2013 Comprehensive Zoning Plan of Howard County in order to adopt the Howard County Zoning Maps and amend the Howard County Zoning Regulations , which include requirements related to zoning districts, permitted uses, accessory uses, temporary uses, nonconforming uses, conditional uses, design standards, density, lot size, building height limits, setbacks, parking, and supplementary regulations; and generally relating to zoning and land use in Howard County.

Council Bill 35-2013 - AN ACT Amending moderate income housing unit provisions to allow certain alternatives to the moderate income housing unit obligation in certain zoning districts; allowing a developer to substitute moderate income housing units by purchasing, rehabilitating, and offering for sale certain existing housing units that are in foreclosure under certain conditions; allowing the substitution of units by offering a certain number of units to certain eligible low-income purchasers who have a certain annual household income; allowing a fee-in-lieu under certain conditions; and generally related to moderate income housing units in Howard County.

Council Bill 36-2013 - AN ACT Increasing the amount of the tax credit available for the restoration and preservation of certain eligible historic properties; increasing the number of years that any unused portion of the tax credit may be carried forward; providing for the application of this Act; and generally related to Howard County tax credits.

Council Resolution 84-2013 - A RESOLUTION Introduced by Courtney Watson, at the request of Linwood Center, Inc. - Endorsing an application by Linwood Center, Inc. to the Maryland Department of Housing and Community Development's Community Investment Tax Credit program providing tax credits for individuals who donate to certain 501(c)(3) organizations.

And Be It Further Enacted by the County Council of Howard County, Maryland that, in case of any conflict between the Agreement and the Fiscal Year 2013 Pay Plan, the Agreement's pay scale for Fiscal Year 2013 for members of the American Federation of State, County and 27 Municipal Employees, Howard County Local 3085, Council 67, AFL-CIO shall take precedence."

On the same page, in line 17, strike "5" and substitute "6".

Any proposed amendment to the proposed zoning map as part of the adoption of a Comprehensive Zoning Ordinance which was not previously proposed, considered or recommended by the Department of Planning and Zoning or the Planning Board shall only be considered by the County Council upon an affirmative vote of two-thirds of the members of the Council. Any person requesting such an amendment shall post the property which is the subject of the request within 72 hours of the introduction of the proposed amendment, with the date, time and location of the hearing on the request. This provision shall not apply to text amendments and noncompliance shall not constitute a basis for setting aside a zoning decision."
