Jim Irvin, Director, and Karen Becker reviewed proposed fees for the Department of Public Works.

The meeting was reopened at 1:50 p.m. The Chair announced that the closed meeting was to obtain legal advice related to Council authorities in approving the operating budget. No votes were taken in the closed meeting.

The work session continued with a discussion of the OPEB (Other Post Employment Benefits) fund and the road construction fund.

Ray Wacks, Budget Director, reported that the Administration plans to submit an amendment to the funds page to conform that fund to the budget resolution.

Josh Felmark and Mark DeLuca spoke on behalf of the Administration regarding the stormwater fees.

Follow-up: Councilman Fox requested planned locations of capital projects and positions funded from revenues from the stormwater fee.

The Chair asked for information about the total cost of the CRM program.

It was announced that there would be a budget work session, if needed, following the public hearing on Monday, May 20, 2013.
