<u>General</u>

Council Bill 34-2012 - AN ACT amending the Pay Plan for Howard County; providing pay scales for police management employees; making certain positions within the Department of Corrections executive exempt; providing for the application of this Act; and generally relating to the Pay Plan for Howard County.

Council Bill 35-2012 - AN ACT amending the Classification Plan for Howard County to amend the classification description for the position of Correctional Program Supervisor III within the Department of Corrections; and generally relating to amendments to the Howard County Classification Plan.

Council Bill 36-2012 (ZRA 144) –Introduced by the Chairperson at the request of the Marsha S. McLaughlin, Director, Department of Planning and Zoning- AN ACT creating a Community Enhancement Floating District; setting forth uses permitted as of right; excluding certain uses; allowing for certain accessory uses; requiring certain moderate income housing; requiring certain density be obtained through the density exchange option or through the neighborhood preservation density exchange option; requiring certain features or amenities as community enhancements; setting forth certain criteria and procedures for the establishment of a Community Enhancement Floating District; requiring certain plans; allowing certain modifications under certain conditions; and generally relating to the Howard County Zoning Regulations.

Council Bill 37-2012 - AN ACT amending PlanHoward 2030, the general plan for Howard County, by defining Growth Tiers, as required by the Maryland Sustainable Growth and Agricultural Preservation Act of 2012; specifying additional designated place types to correspond with the Growth Tiers; revising certain maps to reflect the additional designated place types; adding new text to describe Growth Tiers and adding new maps; and generally relating to planning, zoning and land use in Howard County.

Council Bill 38-2012 (ZRA 140) - Introduced by the Chairperson at the request of Kellogg CCP LLP, c/o Preston Scheffenacker Properties, Inc. - AN ACT amending the Howard County Zoning Regulations to permit the TOD District regulations to allow multi-family dwellings as a permitted use subject to certain criteria; amending the commercial use requirements concerning the building-type; allowing drive-through services subject to certain criteria; generally relating to residential and commercial uses in the TOD zoning district; and generally relating to the Zoning Regulations.

Council Bill 39-2012 (ZRA 142) – Introduced by the Chairperson at the request of Bith Energy, Inc. - AN ACT amending the Howard County Zoning Regulations to permit Commercial Solar Facilities as a Conditional Use in the RC and RR zoning district subject to certain criteria; and generally related to the Zoning Regulations.

Council Bill 40-2012 - Introduced by Calvin Ball, Jennifer Terrasa, and Courtney Watson - AN ACT providing a hiring preference in County government for qualified individuals and veterans with disabilities; providing for policies related to the hiring preference; and generally relating to County hiring practices.

Council Bill 41-2012 - AN ACT amending the allocation categories used in the Housing Unit Allocation Chart, clarifying certain definitions, providing for the application of this Act, and generally relating to adequate public facilities in Howard County.

Council Resolution 156-2012 - Introduced by the Chairperson at the request of COPT Development and Construction Services, LLC A RESOLUTION to close a portion of Riverwood Drive, as shown in Exhibits A and B, in accordance with Section 18.204 of the Howard County Code.

Council Resolution 169-2012 – Introduced by Courtney Watson - A RESOLUTION to encourage the General Assembly to provide the necessary resources to appropriate agencies to implement the use of multidisciplinary teams to address bullying, harassment, and intimidation among students.

Council Resolution 170-2012 - A RESOLUTION adopting the Housing Unit Allocation Chart for Fiscal Year 2013 pursuant to the Adequate Public Facilities Act of Howard County; and providing for a certain effective date.

Council Resolution 171-2012 - A RESOLUTION adopting the Open/Closed Chart, pursuant to the Adequate Public Facilities Act of Howard County, to designate the school regions and school districts that are open for residential development; and providing for a certain effective date.

Council Resolution 172-2012 - A RESOLUTION adding certain sites to the Cemeteries and Grave Sites Inventory.

Council Resolution 173-2012 - A RESOLUTION pursuant to Section 4.201 of the Howard County Code declaring that .4966 acres of land known as a portion of Riverwood Drive owned by Howard County, Maryland is no longer needed by the County for public purposes;

authorizing the County Executive to terminate the property interest, vesting title to the adjacent property owner, 7200 Riverwood LLC, a subsidiary of COPT Development and Construction Services, LLC; waiving the advertising and bidding requirements of Section 4.201 of the Howard County Code; and providing that the County Executive is not bound to terminate the property interest if he finds that it may have a further public use and submits his finding to the County Council for its consideration.

On page 4, in line 23, strike the second "the" and substitute "an".

On page 8, in line 3, after "existing", insert "or a potential future"."

On page 2, in line 6, before "file", insert "On or before December 5, 2012,".

On the same page, in line 7, strike "as soon as practical".

On the same page, in line 9, strike "promptly" and substitute "<u>On or before December 5,</u> <u>2012,</u>".

On the same page, in line 14, strike "and".

On the same page, in line 16, strike "on or before October 31 of each year" and substitute: "within 90 days after the end of the Corporation's fiscal year".

On the same page, in line 19, after "Fund", insert "and;".

On the same page, in line 20, insert:

"6. Include the following in the contract with the Downtown Columbia Partnership required by Section 28.116(c)(4) of the County Code:

a. A requirement that the Corporation comply with the Maryland Public Information Act and the Maryland Open Meetings Act; and b. A provision that Title 28 of the County Code controls in the event of a conflict between the provisions of the contract and the provisions of Title 28".

Substitute the revised list of Columbia Downtown Housing Corporation Directors, Articles of Incorporation, Bylaws, and Memorandum of Understanding attached to this Amendment for the corresponding documents in Attachment A to the Resolution.
