Council Bill 32-2012 - AN ORDINANCE authorizing the issuance, sale and delivery of up to \$100,000,000 consolidated public improvement bonds and up to \$10,000,000 metropolitan district bonds, pursuant to various bond enabling laws; providing that such bonds shall be general obligations of the County; authorizing the County Executive to specify, prescribe, determine, provide for or approve the final principal amounts, maturity schedules, interest rates and redemption provisions for such bonds, and other matters, details, forms, documents or procedures and to determine the method of sale of such bonds; providing for the disbursement of the proceeds of such bonds and for the levying of taxes to pay debt service on such bonds; and providing for and determining various matters in connection therewith.

The Chairperson moved to approve CB32-2012. The motion was seconded by Ms. Watson.

Council Bill 28-2012 - AN ACT establishing a tax credit against the County tax imposed on real property equipped with certain types of accessibility features, under certain conditions; establishing the amount, terms, conditions, and duration of the credit; providing for an application procedure and administration of the credit; and generally relating to property tax credits.

(This amendment adds sensory accessibility features as eligible features.) On page 2, in line 36, strike "OR".

On page 3, in line 2, strike, "TUB." and substitute "TUB; OR

(9) ALARMS, APPLIANCES, AND CONTROLS STRUCTURALLY INTEGRATED

INTO THE 5 UNIT DESIGNED TO ASSIST AN INDIVIDUAL WITH A SENSORY DISABILITY."

The Chairperson moved to approve Amendment 1 to CB28-2012. The motion was seconded by Ms. Watson.

Amendment No. 2.

(This amendment requires the Department of Finance to record certain information regarding property owners who request the property tax credit for home modifications and adds a short title.)

On page 4, in line 19, after "SECTION." insert "THE DEPARTMENT OF FINANCE SHALL SUBMIT A WRITTEN REPORT TO THE COUNTY COUNCIL BY OCTOBER 1 OF EVERY YEAR FOR THE PRECEDING FISCAL YEAR THAT SHALL INCLUDE THE FOLLOWING:

- (1) NUMBER OF APPLICANTS;
- (2) NUMBER OF APPLICATIONS APPROVED;
- (3) INCOME RANGE OF APPLICANTS;
- (4) MODIFICATION MADE BY THE APPLICANT;
- (5) REASON FOR THE MODIFICATION;
- (6) OTHER SOURCES FROM WHICH THE APPLICANT RECEIVED FUNDS OR APPLIED FOR ASSISTANCE FOR THE MODIFICATION;
 - (7) EFFORTS TO ADVERTISE THE CREDIT; AND
 - (8) ANY PROGRAM RECOMMENDATIONS."

Also on page 4, in line 25, insert:

"(I) SHORT TITLE.

THE TAX CREDIT ESTABLISHED UNDER THIS SECTION MAY BE CITED AS "LIVABLE HOMES TAX CREDIT"."

The Chairperson moved to approve Amendment 2 to CB28-2012. The motion was seconded by Ms. Watson.

Amendment No. 3.

(This amendment adds a sunset provision.)

On the title page, in line 4 of the title, after "credit;" insert "providing for the termination of this Act;".

On page 4, in line 27, after "enactment.", insert "<u>It shall remain effective for a period of 5</u> three years and, at the end of the three years, with no further action required by the 6 County

Council, this Act shall be abrogated and of no further force and effect."

The Chairperson moved to approve Amendment 3 to CB28-2012. The motion was seconded by Ms. Watson.

Council Bill 31-2012 (ZRA 139) - AN ACT amending the Howard County Zoning Regulations to require a financial affordable housing obligation or the provision of moderate income housing units in Downtown Columbia; and generally relating to the Howard County Zoning Regulations.

The Chairperson moved to approve CB31-2012. The motion was seconded by Ms. Watson.

down through "Worthington" in line 29 and substitute "<u>in Howard County</u>, including the neighborhoods under review in Case No. 9291,".

On page 2, in line 1, insert a comma after "Resolution".4

Also on page 2, in line 5, after "supply" insert "to the neighborhoods set forth on Exhibit A to this Resolution".

Also in page 2, beginning in line 26, strike "of Braeburn" down through "Worthington" and substitute "set forth in Exhibit A to this Resolution".

On page 3, beginning in line 4, strike "of Braeburn" down through "Worthington" and substitute "identified in Exhibit A to this Resolution".

Also on page 3, in line 8, insert "<u>BE IT FURTHER RESOLVED</u> by the County Council of Howard County, Maryland, that the County Solicitor is directed to take all reasonable and appropriate steps to intervene as a party in Case No. 9291 to promote efficient resolution of the complaint of the County Council without undue duplication.".

Also on page 3, in line 10, after "consolidate" insert "Case No. 9291 with".

Also on page 3, in line 11, strike "with Case No. 9291" and substitute "<u>regarding the</u> neighborhoods identified on Exhibit A that are not under review in Case No. 9291".

Remove Exhibit A as attached to the Resolution and substitute the Exhibit A attached to this Amendment.

The progress of projects for future water supply and sewerage treatment needs in the county and outside of the county, including improvements to the Western Third Zone water supply and expansion of the Patapsco Wastewater Treatment Plant being built in coordination with Baltimore City and Baltimore County; 3. Review of service priorities for properties in the Planned Service Area; and 4. Changes in the anticipated alignment, location, and sizing of future facilities.

On page 1, in line 11, strike "and moderate".

Remove Exhibit 1, as attached to the Resolution as prefiled, and substitute a revised Exhibit 1, as 10 attached to this Amendment.

The Chairperson moved to approve Amendment 1 to CR140-2012. The motion was seconded by Ms. Watson.
