# **APPROVE MINUTES**

# **Financial**

Council Bill 27-2012 - AN ACT for the purpose of authorizing and empowering Howard County, Maryland to borrow money in the aggregate principal amount of up to \$5,216,000 on its full faith and credit, and issue and sell its bonds therefor, to be used to pay costs of Capital Project No. E1027 (Longfellow Elem Addition), more particularly described in the County's 2013 Capital Budget, and to pay costs of issuance of such bonds; authorizing the County to issue bond anticipation notes or to enter into installment purchase agreements for payment of portions of such costs; and to levy taxes upon the assessable property within the County sufficient, together with other available funds, to pay the debt service on such obligations; and providing for and determining various matters in connection therewith.

The Chairperson moved to approve Council Bill 27-2012. The motion was seconded by Ms. Watson.

Council Resolution 113-2012 - A RESOLUTION pursuant to Section 4.201 of the Howard County Code, declaring that certain real property comprising approximately 13.5332 acres owned by Howard County, Maryland located at 6566 Belmont Woods Road, Elkridge, Maryland, known as the "Dobbin Property", is no longer needed by the County for public purposes; authorizing the County Executive to sell the property; waiving the advertising and bidding requirements of Section 4.201 of the Howard County Code; and providing that the County Executive is not bound to sell the property if he finds that it may have a further public use and submits his finding to the County Council for its consideration.

Council Resolution 99-2012 - A RESOLUTION proposing to amend Section 202 "County Council" of the Howard County Charter by changing from three to four the maximum number of terms the Council Members can serve; and submitting this amendment to the voters of Howard County for their adoption or rejection in accordance with Article X of the Howard County Charter and Article XIA of the Maryland Constitution.

The Council Member Ball moved to withdraw Council Resolution 99-2012. The motion was seconded by Ms. Sigaty.

Council Resolution 100-2012 - A RESOLUTION proposing to amend the Howard County Charter to make various technical changes; to amend Section 202 "The County Council" by removing an obsolete factor to be considered in redistricting; to amend Section 501 "The County Board of Appeals" by correcting a citation to the Annotated Code of Maryland; to amend Section 601 "Fiscal year and tax year definitions", Section 615A "Budget Stabilization", and Section 615B "Restrictions on Use of Surplus Revenues" in order to consolidate certain duplicate definitions; to amend Section 709 "Prohibitions" by correcting a typographical error; and submitting this amendment to the voters of Howard County for their adoption or rejection in accordance with Article X of the Howard County Charter and Article XIA of the Maryland Constitution.

The Chairperson moved to approve Council Resolution 100-2012. The motion was seconded by Ms. Watson.

The Chairperson moved to approve Amendment 1 to Council Resolution 100-2012 as follows:

(This amendment removes references to the Metropolitan District.)

On the title page, in line 7, after "definitions;" insert "to amend Section 606 'Action on the annual budget and appropriation ordinance by the County Council' and Section 914 'Definitions and rules of construction' by removing obsolete references;"

On page 3, in line 25, insert the following:

"AND BE IT FURTHER RESOLVED by the County Council of Howard County, Maryland that Section 606 "Action on the annual budget and appropriation ordinance by the County Council", of the Howard County Charter, is hereby amended to read as follows:

# Section 606. - Action on the annual budget and appropriation ordinance by the County Council.

After the public hearing specified in the preceding section [605], the Council may decrease or delete any items in the budget ordinance except those required by the public general laws of this State and except any provisions for debt service on obligations then outstanding or for estimated cash deficits. The Council shall have no power to change the form of the budget as submitted by the Executive, to alter the revenue estimates or to increase any expenditure recommended by the Executive for current or capital purposes unless expressly provided in State law and except to correct mathematical errors. The adoption of the budget ordinance, which shall include only the current expense budget and the capital budget, shall be by the affirmative vote of not less than a majority of the Council on an ordinance to be known as the Annual Budget and Appropriation Ordinance of Howard County. The capital program, as defined in this Charter, shall be adopted by the Council by its separate resolution. Any borrowing to finance capital projects must be authorized by an existing law of the General Assembly of Maryland [[(including laws authorizing borrowing on behalf of the Metropolitan Commission)]] or by a law of the Council adopted in accordance with the Charter. The Council may adopt from time to time bond issue authorization ordinances pursuant to an enabling law or laws then in force and effect to provide the means of financing such capital projects as are to be financed from borrowing. Such bond issue authorization ordinances are not subject to referendum and shall take effect from the date of their enactment. All of said ordinances referred to in this Section shall be exempt from the

executive veto. The Annual Budget and Appropriation Ordinance shall be adopted by the Council on or before the first day of the last month of the fiscal year currently ending, and if the Council fails to do so, the proposed current expense budget submitted by the Executive shall stand adopted, and funds for the expenditures proposed in the current expense budget shall stand appropriated as fully and to the same extent as if favorable action thereon had been taken by the Council."

On page 7, in line 25, insert the following:

AND BE IT FURTHER RESOLVED by the County Council of Howard County, Maryland that Section 914 "Definitions and rules of construction", of the Howard County Charter, is hereby amended to read as follows:

# Section 914. Definitions and rules of construction.

[[(m)] The "Howard County Metropolitan Commission" means the agency appointed by the Howard County Board of County Commissioners in accordance with Chapter 991 of the Acts of the Maryland General Assembly of 1943 and dealt with in Sections 165 through 192 of the Code of Public Local Laws of Howard County (1965 edition as amended and supplemented).]]
[[(n)][(M)] The phrase "two-thirds of the members of the Council" shall mean at least two-thirds of all members and, in the case of a five-member Council, shall mean four members.
[[(o)]](N)] The term "county government" shall include all offices, departments, institutions, boards, commissions, and agencies established under the Howard County Charter, law or resolution, and their officers, agents and employees."

Council Resolution 101-2012 - A RESOLUTION proposing to amend Section 208 "Sessions of the County Council; quorum; rules of procedure", Section 209 "Legislative Procedure", Section 210 "Recording, printing and compilation of laws", and Section 604 "Filing of proposed budget; copies" of the Howard County Charter by changing various publication and advertising requirements to provide that certain information also be made available in at least one electronic medium; proposing to amend Section 209 "Legislative procedure" of the Howard County Charter by permitting the County Council to extend the amount of time to post emergency legislation; and submitting this amendment to the voters of Howard County for their adoption or rejection in accordance with Article X of the Howard County Charter and Article XIA of the Maryland Constitution.

Council Resolution 103-2012 - A RESOLUTION proposing to amend Section 211 "The referendum" of the Howard County Charter by providing that the number of required signatures for a referendum be 5% of the qualified voters of the County calculated upon the whole number of votes cast in the County for Governor at the last preceding gubernatorial election; and submitting this amendment to the voters of Howard County for their adoption or rejection in accordance with Article X of the Howard County Charter and Article XIA of the Maryland Constitution.

Council Resolution 105-2012 - A RESOLUTION proposing to amend Section 613 "Restrictions of capital projects; amendment to capital budget after adoption of budget", of the Howard County Charter to clarify the application of the section to new capital projects; requiring the County Council to establish by law procedures for amending the budget when changes to existing capital projects are approved; and submitting this amendment to the voters of Howard County for their adoption or rejection in accordance with Article X of the Howard County Charter and Article XIA of the Maryland Constitution.

Council Resolution 106-2012 - A RESOLUTION proposing to repeal Section 906 "Copies of books and papers on demand" and Section 907 "Inspection of books, accounts, and papers" of the Howard County Charter and replace them with new Section 906 "Right to Inspect and Copy Public Records"; making the public access provisions of the County Charter consistent with the Maryland Public Information Act; expanding the public right to inspect records to include all persons; permitting persons to obtain copies of public records upon payment of a reasonable fee prescribed by the County Council; and submitting this amendment to the voters of Howard County for their adoption or rejection in accordance with Article X of the Howard County Charter and Article XIA of the Maryland Constitution.

Council Resolution 109-2012 - A RESOLUTION proposing to amend Section 603 "Submission and contents of the County budget" of the Howard County Charter by limiting the amount of contingency funds held in reserve to 3% of each fund in the current expense budget; and submitting this amendment to the voters of Howard County for their adoption or rejection in accordance with Article X of the Howard County Charter and Article XIA of the Maryland Constitution.

The Chairperson moved to approve Council Resolution 109-2012. The motion was seconded by Ms. Watson.

Council Person Fox moved to approve Amendment 1 to Council Resolution 109-2012 as follows:

(This amendment clarifies that the 3% contingency reserves limit applies only to the General Fund and to special funds, and therefore does not apply to internal service funds and other similar funds.)

On page 1, in line 23, strike "OTHER FUND" and substitute: "SPECIAL FUND, INCLUDING EACH FUND WHICH BY LAW HAS A DEDICATED REVENUE SOURCE,";

On the same page, in the same line, after "which", insert "CONTINGENCY RESERVES"; and

On the same page in line 24, after "EACH", insert "SUCH".

contendere to a felony as cause for forfeiture of office by the County Executive; to amend Section 405 "The Office of Law" of the Howard County Charter by adding conviction of or pleading nolo contendere to a felony as a cause for forfeiture of office by the County Solicitor; and submitting this amendment to the voters of Howard County for their adoption or rejection in accordance with Article X of the Howard County Charter and Article XIA of the Maryland Constitution.

Council Bill 26-2012 - AN ACT adopting PlanHoward 2030 as the general plan for Howard County, Maryland, for the purpose of planning for land use and land conservation and multiyear development planning for transportation, public facilities, water, sewerage, parkland, housing, human services, and environmental protection; and generally relating to planning, zoning, and land use in Howard County, Maryland.

The Chairperson moved to approve Council Bill 26-2012. The motion was seconded by Ms. Watson.

The Chairperson moved to approve Amendment 3, 4, 5, 6, 7, 8, 9, 10, 11, and 12 to Council Bill 26-2012, as a group, as follows:

#### Amendment 3:

(*This amendment does the following:* 

- Clarifies the legend on Map 3-1, Major Watershed;
  - Alters language related to watershed protection;
- Adds new implementing action for the Patapsco Heritage Greenway to Policy 3.4 Regional Protection of water resources;
  - Alters the reference to activities related to the agricultural community).

In PlanHoward 2030, as attached to the Bill, make the following changes:

On page 14, in Map 3-1, in the Legend, strike "MAJOR STREAM AND MAJOR

On page 17, strike the second full paragraph and substitute:

"Waste Water Treatment Plant Reductions. Howard County is served by two major WWTPs, the Patapsco and the Little Patuxent. Both plants have assigned pollution caps to meet the Bay TMDL and both plants either have or are currently undergoing upgrades to ENR. The Little Patuxent upgrade was completed in 2012, and the Patapsco upgrade should be completed in 2016."

Also on page 17, strike the fourth full paragraph and substitute:

"The General Assembly in its 2012 legislative session passed HB 987 requiring local governments to institute dedicated sources of funding for stormwater management programs. This legislation requires larger jurisdictions with NPDES permits, such as Howard County, to establish such a fund, often called a stormwater utility fund. Howard County must accomplish this by July 1, 2013."

On pages 19 and 160, under Policy 3.1, in implementing action a, strike "by completing expansion and upgrade of the" and substitute "at the upgraded".

On pages 20 and 161, in Policy 3.4, in the "Implementing Actions" section, insert a new letter "b" which reads:

"<u>b.</u> Patapsco Heritage Greenway. Coordinate with Baltimore County to accomplish certification of the Patapsco Heritage Greenway.". For new Implementing Action 3.4b, note in Appendix A as "On Going".

On page 161, indicate "ongoing" in the time frame column for Policy 3.4(b).

On pages 20 and 161, under Policy 3.5, in implementing action d, strike "to continue". Also, strike "implement" and substitute "expand the use of". At the end of the same sentence, before the period, insert "on local farms".

On pages 20 and 161, under Policy 3.6, in implementing action a, strike "increase" and substitute "continue".

#### Amendment 4:

(This amendment would:

- include the University of Maryland as one of the entities that helps farmers;
- clarify that zoning regulations will provide great flexibility to the agricultural community as well as appropriate protections for rural residents;
- require the County to create a Historic Preservation Plan;
- add a new implementing action letter J for Ellicott City in Policy 4.10 Historic Preservation).

In PlanHoward 2030, as attached to the Bill, make the following changes:

On pages 30 and 163, in Policy 4.2, after "EDA" insert ", the University of Maryland,". On page 31, in implementing action a, after "the EDA" insert ", the University of Maryland,"

"In a rapidly changing economy, Howard County farmers should be able to utilize innovative farming practices so they too can adapt to the evolving market. Enhancing their ability to farm efficiently is critical to the growth of Howard County and its ability to maintain a diverse economy. However, new development plans and conditional uses should include better buffers to reduce conflicts with neighboring residents.".

On pages 34 and 163, strike Policy 4.5 and substitute:

"POLICY 4.5 - Refine the Rural Conservation (RC) and the Rural Residential (RR) zoning regulations to provide greater flexibility for the agricultural community, as well as appropriate protections for rural residents."

On page 40, in the first paragraph, strike the last sentence.

On pages 41 and 164 of the Plan, in "Policy 4.10", immediately before the period, insert "and create an historic preservation plan". In the same policy, in letter "g", after the first period, strike the entire sentence and substitute "Work with historic preservation advocates and other stakeholder groups and create an historic preservation plan to broaden awareness of our heritage and encourage renovation and re-use of historic resources."

On pages 41 and 164, in Policy 4.10, in the "Implementing Actions" section, insert a new letter "j" as follows:

"c. **Differentiate when planning.** Distinguish among the sections along Snowden River Parkway that exhibit different characteristics and merit different treatment.". For new Implementing Action 5.6c, note in Appendix A as "On Going".

As new and revised land use, transportation plans, and funding are developed, the impacts will be reflected in the travel model and are expected to reduce automobile trips. Plan Howard 2030 aims to promote a better balance among all of the County's transportation options."

On page 86, strike Implementing Action "a" in its entirety and substitute:

"a. Green website. Update the County's website that is devoted to providing information to consumers designed to help make Howard County greener, healthier, and sustainable, to address transportation's role in achieving a healthy community. Include emissions calculators and other tools residents can use to measure greenhouse gas savings, map walking or biking distances, organize ridesharing, and access car sharing."

On page 87, in Policy 7.1, strike Implementing Action "c" and substitute:

"c. Safe Routes. Expand, support and promote programs, such as the Safe Routes to

School Program, that will enable communities to make walking and bicycling to
school a safe and routine activity.".

On page 91, in Policy 7.3, after "network" insert "to support future growth in accordance with place type designations.".

Also on page 91, in Policy 7.3, insert a new Implementing Action "c":

"c. Targeted, Strategic Investments. Evaluate new and innovative approaches to maximize the use of highway investments such as High Occupancy Vehicle (HOV) lanes and/or express toll lanes, focus road improvements to support existing communities and future growth areas, and limit rural road improvements to safety, rather than capacity improvements."

On page 119 of the Plan, in Policy 8.15, in implementing action "b" after "sectors" insert "a including faith-based nonprofit organizations,".

On page 120, under Policy 8.16:

In the caption for implementing action "a", strike "New".

Also in implementing action "a", add a second sentence: "Renovate and rehabilitate existing fire stations as appropriate to ensure the continued provision of efficient service.".

On page 121 of the Plan, in Policy 8.17, in implementing action "c", in the first line strike "Continue to" and substitute "Enhance and expand".

As Columbia's Village Centers have matured, there is increasing potential for new projects that take advantage of growing demand for pedestrian- and transit-friendly development. In 2009, the County adopted new zoning for the revitalization of Village Centers in Columbia. *PlanHoward 2030* endorses implementation of these initiatives and supports the continued evolution of the Village Centers using the frameworks established under the Village Center Revitalization zoning process.

Robust connectivity to and among the Village Centers of Columbia and to Downtown Columbia is critical to their long-term health and vitality. Consideration must be given to alternative modes of transportation including maintaining, updating, and expanding bicycle and pedestrian facilities. Revise the NT Zoning Regulations to ensure redevelopment is consistent with the well planned evolution of the Preliminary Development Plan for Columbia, balancing changing market conditions and opportunities with the need to avoid adverse impacts on Village Centers and surrounding properties.

# POLICY 5.8. Enhance the vitality and redevelopment of Columbia's Village Centers and plan for future connections among Village Centers and with other commercial centers.

#### **Implementing Actions**

- a. Strengthen Village Centers. Encourage Village Center property owners, Village
  Boards, and residents to develop and implement Village Center Community Plans
  for enhancing and redeveloping older Village Centers as called for in Council Bill
  29-2009. Collaborate with the Columbia Association to undertake market

In 2004, the Route 40 Corridor Enhancement Study was completed, followed by some rezoning, and adoption of the Route 40 Design Manual.

PlanHoward 2030 endorses implementation of these initiatives and supports the continued evolution of the Route 40 Corridor using the frameworks established under Route 40's Zoning,

Bill 24-2012, which created a process to facilitate and recognize an entity as the

Housing Foundation. Council Bill 24-2012 also implemented a mechanism to

finance the Downtown Columbia Housing Fund."

On page 129, before the heading "**Preservation of Existing Affordable Housing**", insert a new paragraph:

"Howard County recognizes the need and desirability of full-spectrum housing in Downtown Columbia. The County will facilitate the efforts of the Downtown Columbia Housing Foundation and the Downtown Columbia Partnership to leverage developer contributions to the Downtown Housing Fund to use the Fund in agile and innovative ways providing for a variety of housing types for individuals at all income levels."

On page 131, in Policy 9.3:

In implementing action e, add a second sentence: "<u>Facilitate the participation of non-profits in efforts to promote full-spectrum housing.</u>".

On page 177, make the corresponding change to Appendix A. The motion was seconded by Ms. Watson.

The roll call vote called by the Chairperson was: Yea: Council Members Ball, Fox, Sigaty, Terrasa, and Watson.

The motion to approve Amendment 35 to Council Bill 26-2012 passed.

These properties, because of their location at the interface of the rural residential zone and the planned service area, should be designed and zoned to establish a transition that is compatible with and enhances surrounding communities. In addition, they should create an environmental benefit through environmental site design that mitigates impervious surfaces so that storm water will be captured onsite and not affect nearby waterways.".

On page 74, under Policy 6.1, insert a new Implementing Action "a":

"a Limited Planned Service Area Expansion. Zoning requirements for approved
PSA expansions should include a development proposal that is consistent with the
General Plan and establishes a transition that is compatible with and enhances
surrounding communities and provides an environmental benefit.".

Reletter the existing Implementing Actions under Policy 6.1 to accommodate the new Action.

On pages 169 make the corresponding changes to Appendix A. Mark the new Policy 6.1 a as "On-going".
