sidewalk projects, library projects, community college projects, parks and recreation projects, and intersection improvements projects), which are specified and described in the County's 2013 Capital Budget (including, without limitation, borrowings for certain capital projects previously authorized in other calendar years, which such authorization has lapsed or will lapse), and to pay costs of issuance of such bonds; authorizing the County to issue bond anticipation notes or to enter into installment purchase agreements for payment of portions of such costs; and to levy taxes upon the assessable property within the County sufficient, together with other available funds, to pay the debt service on such obligations; and providing for and determining various matters in connection therewith.

Council Bill 21-2012 - AN ACT for the purpose of authorizing and empowering Howard County, Maryland to borrow money in the principal amount of up to \$91,799,179 on its full faith and credit, and issue and sell its bonds therefor, to be used to pay costs of certain County water and sewer capital projects which are specified and described in the County's Capital Budget (including, without limitation, borrowings for certain water and sewer capital projects previously authorized in prior calendar years which such authorization has lapsed or will lapse), and to pay costs of issuance of such bonds; authorizing the County to issue bond anticipation notes or to enter into installment purchase agreements for payment of portions of such costs; and to levy taxes upon the assessable property within the County sufficient, together with benefit assessments, ad valorem taxes levied upon the assessable property in the Metropolitan District and other available funds, to pay the debt service on such obligations; and providing for and determining various matters in connection therewith.

Council Bill 22-2012 - AN ACT for the purpose of authorizing and empowering Howard County, Maryland to borrow money in a principal amount of up to \$22,461,022 on its full faith and credit, and issue and sell its bonds therefor, to be used to pay costs of certain County road construction projects and other capital projects specified and described in the County's 2013 Capital Budget (including, without limitation, borrowings for certain of such capital projects previously authorized), and to pay costs of issuance of such bonds; authorizing and empowering the County to issue bond anticipation notes or to enter into installment purchase agreements for payment of portions of such costs; and to levy taxes upon the assessable property within the County sufficient, together with building excise taxes and other available funds, to pay the debt service on such obligations; and providing for and determining various matters in connection therewith.

Council Bill 11-2012 - AN ORDINANCE authorizing and empowering Howard County, Maryland to issue and sell its refunding revenue bonds, as limited obligations and not upon its full faith and credit in the aggregate principal amount of up to \$6,200,000 in order to refund all of the County's Golf Course Refunding Revenue Bonds, 2003 Series A, which financed or refinanced the costs of the Timbers at Troy golf course; providing that such refunding bonds or other obligations be payable from funds and revenues received from or in connection with such golf course and other funds that may be made available under a financing agreement; providing for the private (negotiated) sale of the bonds; authorizing the execution of a financing agreement; approving the form, manner and tenor of the bonds; authorizing the County Executive to specify, prescribe, determine, provide for or approve certain matters, details, documents or procedures; authorizing the establishment of a debt service reserve fund with respect to the bonds; and providing for and determining various matters in connection therewith.-

Council Bill 12-2012 - AN ACT adopting the International Building Code, 2012, the International Residential Code, 2012, the International Mechanical Code, 2012, and the

International Energy Conservation Code, 2012; providing that such codes collectively comprise the Howard County Building Code; regulating the design, construction, alteration, improvement, or modification of a building, structure, or other related equipment; adopting certain local amendments to the Building Code; adopting penalties for the violation of the Building Code; making certain technical corrections; and generally relating to building and construction regulations in Howard County.

The Chairperson moved to approve Amendment 1 to Council Bill 12-2012 as follows: (*This amendment:*

- 1. Makes a technical correction to reinsert an exception that was inadvertently omitted during the drafting process.
- 2. Clarifies that the replacement of certain alarms is exempt from permit requirements. The installation is not exempt.)

On page 3, after line 19, insert:

"EXCEPTION 3: AGRICULTURAL BUILDINGS. THE PROVISIONS OF THIS CODE SHALL NOT APPLY TO THE CONSTRUCTION, ALTERATION, ADDITION, REPAIR, REMOVAL, DEMOLITION, USE, LOCATION, OR MAINTENANCE OF AGRICULTURAL BUILDINGS. THIS PROVISION DOES NOT EXEMPT THE OWNER OF AN AGRICULTURAL BUILDING FROM OBTAINING REQUIRED ELECTRICAL OR PLUMBING PERMITS OR FROM COMPLYING WITH ALL OTHER APPLICABLE LOCAL, STATE, AND FEDERAL REGULATIONS, LAWS, AND ORDINANCES.".

On page 9, in line 13, strike "INSTALLATION" and substitute "REPLACEMENT".

The motion was seconded by Ms. Watson.

On page 9, in line 15, strike "OR".

Also on page 9, in line 17, after "RECEPTACLES", insert:

"OR;

10. REPLACEMENT OF EXISTING FUEL-GAS-FIRED COOKING EQUIPMENT OR EXISTING FUEL-

GAS-FIRED CLOTHES DRYERS THAT DOES NOT INVOLVE ANY NEW HARD PIPING, ANY NEW

FLEX TUBING, ANY NEW VALVES, OR ANY NEW SIMILAR INFRASTRUCTURE OF ANY KIND"

Council Bill 10-2012 - AN ACT permitting a homeowners association or common ownership community to submit certain documentation that a unit owner seeking a County issued rental license is delinquent on certain fees or violating certain bylaws or covenants; permitting the denial of rental license applications for failing to pay fees or other obligations to the association or community; permitting the denial of a rental license renewal request for failing to pay fees or violating obligations to the association or community; authorizing the Director of the Department of Licenses, Permits and Inspections to suspend or revoke a rental housing license if a homeowners association or common ownership community provides certain documentation indicating a unit owner with a rental license is delinquent on fees or other obligations to the association or community; authorizing the Director of the Department of Licenses, Inspections and Permits to revoke a rental license for false statements on an application; and generally relating to homeowners association and common ownership community fees and obligations, and rental housing licenses.

The Chairperson moved to approve Amendment 1 to Council Bill 10-2012 as follows: (*This amendment*

- 1. changes the definition of common ownership community to include all common ownership communities;
- 2. adds mixed use communities to the definition of common ownership communities;
- 3. grants discretion to the Director of the Department of Inspections, Licenses and Permits to suspend a license; and
- 4. removes the provision allowing the Director to deny, suspend or revoke a license for violations of covenants and bylaws)

On the title page:

- 1. In the third line, strike "or violating certain bylaws or covenants";
- 2. In the fourth line, strike "or other obligations to the association or community";
- 3. In the fifth through the sixth line, strike "or violating obligations to the association or community";
- 4. In the ninth through the tenth line, strike "or other obligations to the association or community".

On page 1, in lines 20 and 23, make the following changes in each instance:

- 1. strike "MULTIFAMILY"; and
- 2. after "RESIDENTIAL" insert "OR MIXED USE" in each instance.

On page 3, beginning in line 24 with "THAT" strike through "OR" in line 25.

On page 4, make the following changes:

- 1. in line 23, strike "THAT:" and substitute "THAT"; and
- 2. strike line 24 in its entirety, and "2." on line 25.

On page 5, make the following changes:

- 1. in line 8, strike "SHALL" and substitute "MAY";
- 2. in line 10, strike "THAT:" and substitute "THAT";
- 3. strike lines 11 through 12 in their entirety, and strike "B." in line 13; and
- 4. strike line 23 in its entirety through the first instance of "OR" in line 24.

On page 6, make the following changes:

- 1. in line 6, strike "THAT:" and substitute "THAT"; and
- 2. strike lines 7 through 8 in their entirety, and "B." in line 9.

The motion was seconded by Ms. Watson.

On page 2, in line 5, after "Housing" insert "AND INCLUDES A LOT AS DEFINED IN THE MARYLAND HOMEOWNERS ASSOCIATION ACT IN TITLE 11B OF THE REAL PROPERTY ARTICLE OF THE ANNOTATED CODE OF MARYLAND".

Also on page 2, in line 9, strike "HOUSING" and substitute "DWELLING".

On page 3, in line 27, after the first instance of "THE" insert "DWELLING".

On page 4, make the following changes:

- 1. in line 5, after the first instance of "THE" insert "<u>DWELLING</u>";
- 2. in line 8, after the second instance of "THE" insert "<u>DWELLING</u>";
- 3. after the first instance of "THE" insert "<u>DWELLING</u>" in the following instances:
 - a. in line 26; and
 - b. in line 29; and
- 4. in line 31, after the second instance of "THE" insert "DWELLING".

On page 5, in line 14, after the first instance of "THE" insert "<u>DWELLING</u>".

On page 6, in line 10, after the first instance of "THE" insert "<u>DWELLING</u>".

homeowners association or common ownership community dues and removes the provision allowing the Director to deny, suspend or revoke a license for violations of covenants and bylaws.)

On the title page, make the following changes:

- in the first line, strike from "permitting" through "covenants" in the third line, and substitute "requiring a homeowner to certify that the homeowners association or common ownership community fees are current for the dwelling unit for which the homeowner is seeking or renewing a rental license";
- 2. In the fourth line, strike "or other obligations to the association or community";
- 3. In the fifth through the sixth line, strike "or violating obligations to the association or community"; and
- 4. In the ninth through the tenth line, strike "or other obligations to the association or community".

On page 3, in line 22, strike from "HOMEOWNERS" through the end of line 27, and substitute "HOMEOWNER THAT HOMEOWNER ASSOCIATION OR COMMON OWNERSHIP COMMUNITY FEES FOR THE DWELLING UNIT ARE NOT MORE THAN 30 DAYS PAST DUE."

On page 4, make the following changes:

- 1. strike line 2 through "SECTION" in line 3;
- 2. in line 18, strike "A.";
- 3. in line 19, strike "AND" and substitute ";";
- 4. in line 20, strike "Code; AND" and substitute "Code, AND HAS PROVIDED UPDATED INFORMATION IN THE RENTAL LICENSE APPLICATION."; and
- 5. strike lines 21 through 26, in their entirety.

On page 5, in line 10 strike from "THAT:" through "B." in line 13, and substitute "THAT". Also on page 5, strike line 23 in its entirety and in line 24 strike "UNIT OR".

On page 6, in line 6, strike "THAT:" and substitute "<u>THAT</u>". Also on page 6, strike lines 7 through 8 in their entirety, and "B." in line 9.

The motion was seconded by Ms. Watson.

The Chairperson moved to approved Amendment 1 to Amendment 4 to Council Bill 10-2012 as follows:

(This amendment permits the Director to deny a rental license if the homeowners association or common ownership community submits proof of a final adjudication for unpaid fees.)

On page 1, in line 19, after "3" insert "and substitute 'AND THE HOMEOWNERS ASSOCIATION OR COMMON OWNERSHIP COMMUNITY HAS NOT SUBMITTED PROOF OF A FINAL ADJUDICATION AGAINST THE HOMEOWNER FOR UNPAID FEES RELATING TO THE UNIT".

The motion was seconded by Ms. Watson.

The roll call vote called by the Chairperson was: Yea: Council Members Ball, Fox, Sigaty, Terrasa and Watson.

The motion to approve Amendment 1 to Amendment 4 to Council Bill 10-2012 passed.
