# **Meeting Minutes - Approved**

Legislative Work Session Monday, February 24, 2025 Hybrid Meeting (Virtual and In-Person Meeting) Video Streamed on <u>https://cc.howardcountymd.gov/watch-us</u> 9:30 a.m.

The Work Session was called to order at 9:33 am.

- **CR45-2025** Introduced by The Chairperson at the request of the County Executive *Short Title:* Easement 0.0357 acres Baltimore Gas and Electric County Property along Church Ave.

Emily Iacchei, chief of Real Estate Services in Howard County Department of Public Works (DPW), was present to give an overview of CR44 and CR45-2025, along with staff from Baltimore Gas and Electric (BGE).

Sonya Harbaugh, Director of Strategy for BGE, introduced the other BGE staff present, and gave a presentation of the purpose and benefits of larger grid fiberoptic middle-mile infrastructure project that BGE is undertaking. She was assisted by Candace Butterworth, Senior Strategy Manager, Anthony Marshall, Senior Real Estate Representative, and Dan Fleming, Project Manager.

According to BGE, the benefits of the underground fiberoptic included improved capacity & resiliency, greater digital equity and affordability. Other topics discussed included an overview of the Investment Infrastructure and Jobs Act (IIJA) grant award received by BGE and other utilities nationwide, a route overview of the Grid Communications and Connectivity program, the specific sections the CR44 and CR45 easement requests cover, and reasons for the deviation requests.

Ms. Butterworth mentioned the Rockburn Park access is a "Critical Pathway" in meeting internet infrastructure connection, and additional reroutes would be very costly to BGE.

Further discussion and questions amongst Council members ensued. Topics included the factors that lead to increased BGE rates amongst Howard County ratepayers, additional construction costs of the project, offsetting costs for customers and shareholders, potential third-party internet providers and data centers, and meeting future electrifications and communications demand.

# The Council requested:

- Corporate financial disclosure information for BGE shareholders. BGE commented that this information will be disclosed through finalized period of performance with NDIA (2027).
- Amount spent by BGE on lobbyists to Maryland State Legislature.
- Status of Bills in Annapolis that deal with renewable energy projects and transmission lines.
- Total percentage of increased distribution rates.
- Information on benefits of underground reclosure networks.
- A copy of the letter of support from Howard County to BGE for the IIJA Grant Award, dated August 2022.

The meeting was adjourned at 12:00pm.
