# Agenda

#### 1. Federal and State Budget Impact on Howard County

Michael Bayrd, Director of Intergovernmental Affairs of the Maryland Comptroller's Office discussed Federal and State budget impacts on Howard County. Mr. Bayrd informed the Council of the March Board of Revenue Estimates meeting, where concerns about the Federal and State budget were discussed as well as the impact on Maryland from recent reductions in force of the federal labor force. Due to uncertainty over federal government actions the Comptroller's Office lowered their withholding forecast to 2.4%.

There was general discussion about the Federal and State fiscal situations and their impact on the County. There was also discussion of the State budget shifting costs to counties such as pension cost shifts and damages from wrongful convictions. Maureen Evans, Director of Government

### 2. Council Resolution 63-2025

Mr. Cornell Brown, Chief Operating Officer, Howard County Public Schools Mr. David Lubley, Executive Director, Capital Planning and Construction, Howard County Public Schools, Jolene Mosley, Chair of the Howard County School Board, Felix Facchine, Deputy Chief of Staff, Howard County Executive, Maureen Evans, Director of Government Affairs for the Howard County Executive were present to answer questions regarding Council Resolution 63-2025.

There was general discussion among the Council and Howard County Public Schools representatives. Topics of discussion included why a supplemental request to the Maryland Interagency Commission on School Construction ("IAC") was made, where additional funds originated, and how the projects included in the supplemental request were identified. Mr. Brown outlined the procedure the school system undergoes when determining what school capital projects should be included in the request to the IAC.

There was then a general discussion about the cost of capital projects and the availability of State funds for those projects as well as what processes the School Board uses to ensure that the County is maximizing available state funds for capital projects. It was stated that the cost of projects, condition of existing facilities, and available funds are all factors considered in identifying projects.

The Committee gave a presentation outlining the County's 2026 Fiscal Year expectations. The Committee discussed the County's financial outlook, demographic trends, revenue sources, and risk factors. The Committee also put forth recommendations
