Erin Sherman from the Rocky Mountain Institute ("RMI") testified about various options for amendments to the proposed Internation Code Council Building Codes pending before the Council. Ms. Sherman presented the Council draft model code amendment language options. Councilmembers discussed the various amendment options presented by Ms. Sherman and RMI for both residential and commercial buildings including electric readiness, potential of legal challenges and costs.

Bob Francis the Director of the Howard County Department Inspections, Licenses, and Permits testified regarding implementation of the County's building codes

CR 113-School Capacity Chart

Councilmembers asked representatives of the Howard County Public School Schools ("HCPSS") questions about the enrollment projections for upcoming school years. HCPSS representatives Cornell Brown, Ebony Langford-Brown, Tim Rodgers, David Lubeley discussed the process the school system uses to project enrollment including the use of a feasibility study to determine Pre-Kindergarten enrollment. Councilmembers asked about the ramifications of Pre-Kindergarten seats not being included in the enrollment projections and how school enrollment projects would be affected if those seats were included int the enrollment projections.

- 1. What are the number of rooms and square footage designated for PreK?
- 2. What are the enrollment numbers for PreK?
- 3. What would the Open/Close chart look like if PreK numbers were included?
