Stephen LeGendre, Administrator to the County Council; Margaret Ann Nolan, County Solicitor; James Vannoy, Assistant County Attorney; David Nitkin, Director of policy and legislative affairs; and Jeffery Meyers, Legislative Analyst were also present.

### **COUNCIL OFFICERS**

Council Bill No. 51-2011 - Introduced by Calvin Ball - AN ACT authorizing the Department of Police to impound a vehicle under specified circumstances; specifying the criteria for release of the vehicle; and generally relating to parking violations in Howard County.

The Chairperson moved to remove Council Bill No. 51-2011 from the Table. The motion was seconded by Ms. Watson.

The roll call vote called by the Chairperson on the motion was: Yea: Council Members Ball, Fox, Sigaty, Terrasa and Watson.

Council Bill No. 51-2011 was removed from the Table.

The Chairperson moved to approve Council Bill No. 51-2011. The motion was seconded by Ms. Watson.

The Chairperson moved to approve Amendment 1 to Council Bill No. 51-2011 as follows:

(This amendment changes the parameters that must be met before an impoundment.)

On page 1, strike lines 14 and 15 in their entirety and substitute:

- "(1) This section applies to a motor vehicle parked on a public street in Howard County that is:
- (I) PARKED ILLEGALLY AND AGAINST WHICH THERE IS ONE OR MORE UNSATISFIED PARKING VIOLATIONS; OR
- (II) PARKED LEGALLY AND AGAINST WHICH THERE ARE TWO OR MORE UNSATISFIED PARKING VIOLATIONS."

Also on page 1, in line 18, after "(I)" insert "1. FOR A VEHICLE WITH ONE UNSATISFIED PARKING VIOLATION," and, also in line 18, strike "ANY" and substitute "THE".

Also on page 1, in line 19, strike "AND" and substitute "OR".

Also on page 1, after line 19, insert "2. Otherwise, at least 30 days has elapsed since the most recent unsatisfied parking violation was issued and at least 90 days has elapsed since any other unsatisfied parking violation was issued; and"

The motion was seconded by Ms. Watson.

The roll call vote called by the Chairperson on the motion was: Yea: Council Members Ball, Fox, Sigaty, Terrasa and Watson.

Amendment No. 1 to Council Bill No. 51-2011 was approved.

The Chairperson moved to approve Amendment 3 to Council Bill No. 51-2011 as follows:

(This amendment limits impoundment to commercial vehicles in specified areas.)

On the title page, in the purpose paragraph, strike "impound a vehicle" and substitute "<u>impound</u> a certain vehicle"; after "circumstances;", insert "<u>specifying the area where an impoundment</u> may occur;".

On page 1, in line 14, before "MOTOR" insert "COMMERCIAL".

Also on page 1, in line 15, after "VIOLATIONS" insert ", IF THE STREET IS IN OR ADJACENT TO:

- (I) A RESIDENTIAL AREA; OR
- (II) PROPERTY ZONED FOR RESIDENTIAL USE.".

The motion was seconded by Mr. Fox.

The roll call vote called by the Chairperson on the motion was: Yea: Council Members Ball, Fox, Sigaty, Terrasa and Watson.

Amendment No. 3 to Council Bill No. 51-2011 was approved.

The Chairperson moved to approve Amendment 2 to Council Bill No. 51-2011 as follows:

(This amendment sets the date when enforcement may begin.)

On page 2, before line 36, insert "Section 2. And Be It Further Enacted by the County Council of Howard County, Maryland that the Department of Police shall not impound a vehicle under this Act before March 1, 2012."

Also on page 2, in line 37, strike "Section 2." and substitute "Section 3.".

The motion was seconded by Ms. Watson.

The roll call vote called by the Chairperson on the motion was: Yea: Council Members Ball, Fox, Sigaty, Terrasa and Watson.

Amendment No. 2 to Council Bill No. 51-2011 was approved.

The roll call vote called by the Chairperson on Council Bill No. 51-2011 as amended was: Yea: Council Members Ball, Fox, Sigaty, Terrasa and Watson.

Council Bill No. 50-2011 passed as amended.

Council Bill No. 54-2011 - Introduced by Council Members Calvin Ball, Mary Kay Sigaty, Jennifer Terrasa and Courtney Watson - AN ACT amending the Health and Social Services Title of the Howard County Code to include gender identity and expression as a classification protected against certain types of unlawful, discriminatory practices; and generally relating to the Human Rights law of Howard County.

The Chairperson moved to approve Council Bill No. 54-2011. The motion was seconded by Ms. Watson.

The roll call vote called by the Chairperson on the motion was: Yea: Council Members Ball, Sigaty, Terrasa and Watson; No: Mr. Fox.

Council Bill No. 54-2011 passed.

Council Bill No. 55-2011 - Introduced by Calvin Ball, Co-sponsored by, Courtney Watson - AN ACT authorizing a property tax credit for certain residential buildings that meet specified environmental standards; providing for the amount and duration of the credit; and generally relating to property tax credits.

The Chairperson moved to approve Council Bill No. 55-2011. The motion was seconded by Ms. Watson.

The Chairperson moved to approve Amendment 1 to Council Bill No. 51-2011 as follows:

(This amendment (1) specifies that a high performance building includes one that attains the silver certification level of the National Green Building Standard if DILP finds that the standard is equivalent to LEED silver or better, (2) requires an R-2 or R-3 building to meet a certain HERS standard or be Energy Star Qualified, (3) sets the credit for specified LEED or equivalent ratings, and (4) sets a cap for an individual credit.)

On the Title page, in the purpose paragraph, after "standards;" insert "<u>altering a certain definition</u>;". On page 1, after line 18, insert:

"(II) ACHIEVES AT LEAST A SILVER CERTIFICATION LEVEL OF THE NATIONAL GREEN BUILDING STANDARD ICC-700 IF THE DIRECTOR OF THE DEPARTMENT OF INSPECTIONS, LICENSES AND PERMITS FINDS THAT THE STANDARD IS EQUIVALENT TO AT LEAST A SILVER RATING ACCORDING TO THE U.S. GREEN BUILDING COUNCIL'S LEED (LEADERSHIP IN ENERGY AND ENVIRONMENTAL DESIGN) RATING SYSTEM;"

Also on page 1, in line 19, strike "(ii)" and substitute "(III)".

Also on page 1, in line 23, strike "(iii)" and substitute "(IV)".

On page 2, strike lines 13 through 23 in their entirety and substitute:

- "(D) AMOUNT AND DURATION OF CREDIT FOR R-2 AND R-3 BUILDINGS.
  - (1) THIS SUBSECTION APPLIES TO AN R-2 OR R-3 BUILDING THAT:
  - (I) ACHIEVES AT LEAST A SILVER RATING UNDER THE LEED FOR HOMES RATING
    SYSTEM OR A COMPARABLE RATING SYSTEM THAT THE DIRECTOR OF INSPECTIONS, LICENSES
    AND PERMITS MAY ADOPT BY REGULATION; AND
    - (II) 1. HAS A HOME ENERGY RATING SYSTEM SCORE OF 70 OR LESS; OR
      - 2. IS AN ENERGY STAR QUALIFIED HOME.
  - (2) THE TAX CREDIT UNDER THIS SUBSECTION FOR A BUILDING THAT HAS A LEED PLATINUM OR EQUIVALENT RATING IS A PERCENTAGE OF THE TOTAL COUNTY PROPERTY TAX CREDIT ASSESSED ON THE BUILDING AS FOLLOWS:
    - (I) FIRST YEAR: 100 PERCENT;
    - (II) SECOND YEAR: 75 PERCENT;
    - (III) THIRD YEAR: 50 PERCENT; AND
    - (IV) FOURTH YEAR: 25 PERCENT.
  - (3) THE TAX CREDIT UNDER THIS SUBSECTION FOR A BUILDING THAT HAS A LEED GOLD OR EQUIVALENT RATING IS A PERCENTAGE OF THE TOTAL COUNTY PROPERTY TAX CREDIT ASSESSED ON THE BUILDING AS FOLLOWS:

- (I) FIRST YEAR: 90 PERCENT;
- (II) SECOND YEAR: 68 PERCENT;
- (III) THIRD YEAR: 45 PERCENT; AND
- (IV) FOURTH YEAR: 23 PERCENT.
- (4) THE TAX CREDIT UNDER THIS SUBSECTION FOR A BUILDING THAT HAS A LEED SILVER OR EQUIVALENT RATING IS A PERCENTAGE OF THE TOTAL COUNTY PROPERTY TAX CREDIT ASSESSED ON THE BUILDING AS FOLLOWS:
  - (I) FIRST YEAR: 75 PERCENT;
  - (II) SECOND YEAR: 56 PERCENT;
  - (III) THIRD YEAR: 38 PERCENT; AND
  - (IV) FOURTH YEAR: 19 PERCENT.
- ((5) (I) IN ONE FISCAL YEAR, THE TAX CREDIT UNDER THIS SUBSECTION MAY NOT EXCEED \$5,000 PER BUILDING; PROVIDED, HOWEVER, THAT EACH OWNER OCCUPIED UNIT IS ALLOWED A CREDIT NOT TO EXCEED \$5,000.
  - (II) EXCESS CREDITS SHALL NOT BE CARRIED OVER TO FUTURE YEARS."

The Chairperson moved to approve Amendment 1 to Amendment 1 to Council Bill No. 51-2011 as follows:

(This amendment requires R2 and R3 buildings to be "high performance buildings" and deletes references to the home energy rating system and energy star qualification.)

In line 15, before "R-2" insert "HIGH PERFORMANCE".

Strike lines 20 and 21 and substitute "(II) IS A HIGH PERFORMANCE BUILDING."

The motion was seconded by Ms. Watson.
