#### BA 799D Kincade, LLC

Appeal of BA 799D / BA 801D (consolidated) Decision and Order of the Howard County Hearing Examiner by HRD (Lakefront Neighborhood – Phase 1, Little Patuxent Pkwy).

All members present confirmed that they completed a site visit of the subject property.

The Board discussed consolidating the de novo cases BA 799D and BA 801D. The Board discussed also consolidating the on the record cases BA 800D and BA 802D. The Board requests the parties to file joint motions for the consolidation of these cases.

The Board will hear cases BA 800D and BA 802D first and then will subsequently schedule BA 799D and BA 801D.

The Board agreed to allow Jessica Haire, Esquire on behalf of IMH Columbia to file an amended memorandum for BA 802D within 10 days and will allow opposition the opportunity to respond.

The Board requests the parties to provide a memorandum for BA 799D and BA 801D which contains points of law, pertinent published legal opinions and prior board decisions, a summary of preliminary legal issues for the Board's consideration, and standards of evaluation for the Board to contemplate when determining findings of fact and conclusions of law. Page limit of 10 single-spaced pages is due in 30 days. The Chair will submit an Order.

The next hearing date to continue these cases will be determined. The hearing date for BA 801D and BA802D is scheduled for January 23, 2025.
