- (c) Amount and Duration of Credit for Certification in LEED Core and Shell or New Construction Rating Systems. For a high performance building that is certified in the LEED 2009 rating system for core and shell [[version 2.0 or new construction version 2.2]] or a comparable rating system that the Director of Inspections, Licenses and Permits may adopt by regulation:
 - (1) The amount of the tax credit is a percentage of the total County property tax assessed on the high performance building as follows:

- (i) LEED certified silver--25 percent;
- (ii) LEED certified gold--50 percent;
- (ii) LEED certified platinum--75 percent; and
- (d) Amount and Duration of Credit for Certification in Existing Building Rating System. For a high performance building that is certified in the LEED 2009 rating system for existing buildings [[version 2.0]] or a comparable rating system that the Director of Inspections, Licenses and Permits may adopt by regulation:
 - (1) The amount of the tax credit is a percentage of the total County property tax assessed on the high performance building as follows:
 - (i) LEED certified silver--Ten percent;
 - (ii) LEED certified gold--25 percent;
 - (iii) LEED certified platinum--50 percent; and
 - (2) The tax credit authorized by this subsection continues for three years.".

On page 3, in line 1, strike "2" and substitute "3". On page 3, in line 6, strike "3" and substitute "4".

The motion was seconded by Ms. Terrasa.

- "(B) HIGH SCHOOL MEMBERS OF BOARDS AND COMMISSIONS.
 - (1) A HIGH SCHOOL STUDENT MEMBER OF A BOARD OR COMMISSION LISTED IN SUBSECTION (A)(3) OF THIS SECTION SHALL FILE A STATEMENT OF FINANCIAL INTEREST THAT THE ETHICS COMMISSION PROVIDES.

- (2) THE HIGH SCHOOL STUDENT MEMBER STATEMENT SHALL ONLY INCLUDE THE FOLLOWING INFORMATION:
 - A SCHEDULE OF SOURCES OF EARNED INCOME OF THE HIGH SCHOOL STUDENT MEMBER AND OF THE MEMBER'S PARENT(S) OR LEGAL GUARDIAN(S) THAT EXCEED \$100.00, INCLUDING THE NAME AND ADDRESS OF EACH PLACE OF SALARIED EMPLOYMENT AND OF EACH BUSINESS ENTITY SOLELY OR PARTIALLY OWNED AND FROM WHERE INCOME WAS EARNED. WHERE THE SOURCE OF INCOME IS AN ATTORNEY-CLIENT OR A PHYSICIAN/PSYCHIATRIST/PSYCHOLOGIST-PATIENT RELATIONSHIP, THE NAMES OF INDIVIDUAL CLIENTS OR PATIENTS NEED NOT BE DISCLOSED.
 - A SCHEDULE OF EACH GIFT IN EXCESS OF \$50.00 IN VALUE (OR AN (ii) AGGREGATE OF \$100.00 FROM ANY ONE PERSON) DIRECTLY OR INDIRECTLY FROM A PERSON(S) WHO DOES BUSINESS WITH HOWARD COUNTY. THIS SCHEDULE AS TO EACH SUCH GIFT, SHALL INCLUDE:
 - THE NATURE AND VALUE OF THE GIFT; AND
 - b) THE IDENTITY OF THE PERSON FROM WHOM, DIRECTLY OR INDIRECTLY, THE GIFT WAS RECEIVED.
 - c) FOR PURPOSES OF THIS SUBSECTION, GIFT DOES NOT INCLUDE:
 - I) CEREMONIAL GIFTS OR AWARDS OF INSIGNIFICANT MONETARY VALUE; OR
 - II) UNSOLICITED GIFTS OF NOMINAL VALUE OR TRIVIAL ITEMS OF INFORMATIONAL VALUE.
 - (iii) A LIST OF ANY PARENT(S) OR LEGAL GUARDIAN(S) EMPLOYED BY THE COUNTY IN ANY CAPACITY."

Renumber the remaining sections accordingly.

On page 2, in line 21 add:

"Section 2. And Be It Further Enacted by the County Council of Howard County, Maryland, that subsection (c) of Section 22.205 "Financial Disclosure" of Subtitle 2 "Public Ethics" of Title 22 "General Provisions, Penalties and Rules of Interpretation" of Howard County Code is amended to read as follows:

(c) Contents of Statements of Financial Interest: The sworn statement required to be filed by this subtitle shall be upon a form prescribed by the ethics commission. EXCEPT AS PROVIDED IN SUBSECTION (B) OF THIS SECTION, [[It]] THE STATEMENT shall disclose the following interests of the person making the statement for the calendar year for which the required statement is filed:"

Renumber the remaining enactment clause accordingly.

The motion was seconded by Ms. Terrasa.

The Chairperson moved to adopt Amendment No. 1 to Amendment No. 1 to Council Bill No. 48-2009 as follows: (This amendment makes certain technical changes.)

On page 1, in line 8 after "INTEREST" insert "ON A FORM".

On page 2, in line 13 strike "Renumber the remaining sections accordingly."

On page 2, in line 27 insert:

"Section 3. And Be It Further Enacted by the County Council of Howard County, Maryland, that subsections (b),(c),(d) and (e) of Section 22.205 "Financial Disclosure" of Subtitle 2 "Public Ethics" of Title 22 "General Provisions, Penalties and Rules of Interpretation" of the Howard County Code be renumbered as (c), (d), (e), and (f)."

Council Resolution No. 77-2009 – Adopting a fee-in-lieu for a waiver of the Howard County Green Buildings Law

The Chairperson moved to adopt Amendment No. 1 to Council Resolution No. 77-2009 as follows: (*This amendment would create an application fee for the Green Buildings Law waiver and decrease the fee-in-lieu*).

On the title page, in the title, after "adopting", insert "an application fee and".

On page 1, in line 23, strike the period and substitute "; and". And immediately following line 24, insert: "WHEREAS, upon recommendation by the County Council, an application fee has been proposed for the processing and review of the Green Buildings Law waiver application by the Department of Inspections, Licenses and Permits.".

On page 1, in line 26, after "following", insert "application fee and". On the same page, strike line 28, in its entirety, and substitute the following:

"Green Buildings Law Waiver Application Fee: \$750 (to be credited against the fee-in-lieu total, if the fee-in-lieu is approved)

<u>Fee-In-Lieu:</u> \$1.50 per gross square-foot".

On page 1, in line 30, after "this", insert "application fee and".

The motion was seconded by Ms. Terrasa.

Amendment No. 1 to Council Resolution No. 77-2009 failed.

- 2. Update of the water and sewer facilities maps to reflect entries into the Metropolitan District

Council Resolution No. 80-2009 – Amending the rules that implement the Settlement Downpayment Loan Program established under Title 13, Subtitle 9 of the Howard County Code, the Homeownership Assistance Program; defining certain terms; amending certain definitions; providing for different types of loans; setting forth eligibility criteria and loan amounts; clarifying the use of loans; clarifying certain application procedures; making certain technical corrections; and generally relating to the Settlement Downpayment Loan

The Chairperson moved to adopt Council Resolution No. 80-2009. The motion was seconded by Ms. Terrasa.

The Chairperson moved to adopt Amendment No. 1 to Council Resolution No. 80-2009 as follows: (*This amendment*:

- 1. On page 3, in Section 02.B, in paragraph (15) entitled "Primary lender", after "REGULATION" insert:
 - ";AND (B) AN APPROVED SELLER/SERVICER OF FEDERAL HOUSING ADMINISTRATION, FANNIE MAE, FREDDIE MAC, OR OTHER MORTGAGE LOANS MADE UNDER A SIMILAR FEDERAL OR STATE HOUSING FINANCE AGENCY".
- 2. On page 6, in Section 05.C entitled "Assets", in new paragraph (1), strike "TWO" and substitute "ONE" and, in the same line, strike "PAYMENTS" and substitute "PAYMENT".
- 3. On page 7, in Section 05.E entitled "Credit", after "lender." insert "<u>AN APPLICANT</u> SHALL BE DEEMED INELIGIBLE IF THE APPLICANT HAS FAILED TO PAY ANY PREVIOUS LOAN MADE TO THE APPLICANT BY THE DEPARTMENT.".
- 4. On page 7, in proposed Section 05.F entitled "Applicant's contribution":
 - a. Strike "the greater of:" and insert "THE GREATER OF:";
 - b. Strike "(1)" and substitute "(1)";
 - c. Strike "; or" and substitute "; OR"; and
 - d. Strike "(2) \$1,000.00." and substitute "(2) \$1,000.".

The motion was seconded by Ms. Terrasa.

The roll call vote called by the Chairperson on Amendment No. 1 was: Yea: Council Members Sigaty, Ball, Fox, Terrasa and Watson.

Amendment No. 1 to Council Resolution No. 80-2009 passed.

The Chairperson moved to adopt Amendment No. 2 to Council Resolution No. 80-2009 as follows: (*This amendment changes the workforce development loan regulations by requiring the borrower to provide proof of continuous employment in Howard County.*)

In the Settlement Downpayment Loan Program, attached to the Resolution as Exhibit A, on page 10, strike Section 09.F, entitled "Workforce Initiative Loan- Principal Reduction," in its entirety

and substitute the language attached to this amendment.

F. WORKFORCE INITIATIVE LOAN – PRINCIPAL REDUCTION.

- (1) PROVIDED THAT THE BORROWER COMPLIES WITH PARAGRAPH (2) OF THIS SUBSECTION F, THE PRINCIPAL BALANCE OF A WORKFORCE INITIATIVE LOAN SHALL BE REDUCED BY 10% OF THE ORIGINAL LOAN AMOUNT ON EACH ANNIVERSARY OF THE LOAN. AT THE END OF THE FULL LOAN TERM, ALL PRINCIPAL AND ACCRUED INTEREST PAYMENTS SHALL BE FORGIVEN.
- (2) (A) IN ORDER TO QUALIFY FOR A PRINCIPAL REDUCTION, THE BORROWER MUST SUBMIT TO THE DEPARTMENT DOCUMENTARY EVIDENCE THAT AT LEAST ONE MEMBER OF THE BORROWER'S HOUSEHOLD HAS BEEN CONTINUOUSLY EMPLOYED FULL-TIME IN HOWARD COUNTY FOR THE TERM OF THE LOAN.
- (B) SUCH EVIDENCE MUST BE SUBMITTED AT LEAST 30 DAYS PRIOR TO THE EARLIER OF (I) A SALE, REFINANCING, OR OTHER EVENT LISTED IN RULE 09.E THAT WOULD OTHERWISE RESULT IN THE FULL OR PARTIAL REPAYMENT OF THE LOAN, OR (II) THE END OF THE TERM OF THE LOAN.
- (C) SUCH EVIDENCE SHALL BE IN A FORM PRESCRIBED OR APPROVED BY THE DEPARTMENT.
- (D) IF THE BORROWER'S HOUSEHOLD MEMBER HAS BEEN EMPLOYED IN HOWARD COUNTY FOR ONLY A PORTION, BUT NOT ALL, OF THE TERM OF THE LOAN, THEN THE DEPARTMENT WILL PRO RATE THE PRINCIPAL REDUCTION FOR THAT TIME DURING WHICH THE HOUSEHOLD MEMBER WAS EMPLOYED IN HOWARD COUNTY. THE REMAINING PRINCIPAL BALANCE WILL BECOME DUE AND OWING UPON ANY OF THE EVENTS LISTED IN RULE 09.E.

The motion was seconded by Ms. Terrasa.

The roll call vote called by the Chairperson on Amendment No. 2 was: Yea: Council Members Sigaty, Ball, and Fox; Nay: Council Members Terrasa and Watson.

Amendment No. 2 to Council Resolution No. 80-2009 passed.

Council Resolution No. 80-2009 passed as amended.

Council Resolution No. 81-2009 – Endorsing the provision of financing by the State Department of Business and Economic Development for an economic development project in Howard County; designating the Howard County Economic Development Authority as the agency to administer the project; and certifying that the project is consistent with the County's plan for economic development

The Chairperson moved to adopt Council Resolution No. 81-2009. The motion was seconded by Ms. Terrasa.
