The Chairperson moved to adopt Amendment No. 1 to Council Bill No. 62-2008 as follows: (*This amendment would correct a typographical error in the sponsorship lines of the title page*).

On the title page, in line 1 of the sponsorship lines, strike the "and" and substitute a comma. In the same line, immediately following "Sigaty", insert ", and Jennifer Terrasa". Also on the same page, strike line two of the sponsorship line, in its entirety.

- (I) EXCEPT AS PROVIDED IN SUBSECTION (IV), THE MODERATE INCOME HOUSING UNIT ALLOCATIONS SHALL BE USED FOR MODERATE INCOME HOUSING UNITS THAT SATISFY THE MODERATE INCOME HOUSING UNIT PROVISIONS OF TITLE 13 OF THIS CODE;
- (II) A DEVELOPMENT MAY ONLY RECEIVE MODERATE INCOME HOUSING UNIT ALLOCATIONS FOR THE NUMBER OF MODERATE INCOME HOUSING UNITS THAT ARE REQUIRED BY THE ZONING REGULATIONS, EXCEPT THAT IF A DEVELOPER PROFFERS MORE MODERATE INCOME HOUSING UNITS THAN IS REQUIRED BY THE ZONING REGULATIONS, THE DEVELOPMENT MAY RECEIVE ADDITIONAL MODERATE INCOME HOUSING UNIT ALLOCATIONS FOR THE PROFFERED UNITS;
- (III) NO MORE THAN ONE-THIRD OF ALL OF THE UNITS IN A DEVELOPMENT MAY RECEIVE MODERATE INCOME HOUSING UNIT ALLOCATIONS;
- (IV) MODERATE INCOME HOUSING UNIT ALLOCATIONS MAY BE USED FOR MARKET RATE HOUSING UNITS IF:
 - A. THE DEVELOPMENT IS A MULTI-YEAR PHASED PROJECT; AND
 - B. IN EACH PHASE OF CONSTRUCTION, THE PERCENTAGE OF MODERATE INCOME HOUSING UNITS IS NO LESS THAN THAT REQUIRED BY THE ZONING REGULATIONS; AND
- (V) THE SUBDIVISION OR SITE DEVELOPMENT PLAN, INCLUDING THE MODERATE INCOME HOUSING UNITS, IS SUBJECT TO THE TESTS FOR ADEQUATE ROAD FACILITIES AND ADEQUATE PUBLIC SCHOOL FACILITIES AS PROVIDED IN SECTIONS 16.1101 AND 16.1103 OF THIS CODE.".

On pages 3 and 4, strike lines 24 through 31 and 1 through 17 respectively.

On page 4, in line 19, strike "3" and substitute "2".

The motion was seconded by Ms. Terrasa.

The roll call vote called by the Chairperson on Amendment No. 2 was: Yea: Council Members Sigaty, Ball, Fox, Terrasa and Watson.

Amendment No. 2 to Council Bill No. 62-2008 passed.

The Chairperson moved to adopt Amendment No. 3 to Council Bill No. 62-2008 as follows: (*This amendment would retain the MIHU allocation section in Section 16.1102, allow the MIHU allocations to be used for market rate housing units for developments containing MIHUs, and specify that no more than 50 MIHU allocations can be used for a given project in a given year*).

On the title page, strike the entire title and insert:

On page 3, immediately following line 23 insert:

- (I) EXCEPT AS PROVIDED IN SUBSECTION (IV), THE MODERATE INCOME HOUSING UNIT ALLOCATIONS SHALL BE USED FOR MODERATE INCOME HOUSING UNITS THAT SATISFY THE MODERATE INCOME HOUSING UNIT PROVISIONS OF TITLE 13 OF THIS CODE;
- (II) A DEVELOPMENT MAY ONLY RECEIVE MODERATE INCOME HOUSING UNIT
 ALLOCATIONS FOR THE NUMBER OF MODERATE INCOME HOUSING UNITS
 THAT ARE REQUIRED BY THE ZONING REGULATIONS, EXCEPT THAT IF A
 DEVELOPER PROFFERS MORE MODERATE INCOME HOUSING UNITS THAN IS
 REQUIRED BY THE ZONING REGULATIONS, THE DEVELOPMENT MAY RECEIVE
 ADDITIONAL MODERATE INCOME HOUSING UNIT ALLOCATIONS FOR THE
 PROFFERED UNITS;
- (III) NO MORE THAN ONE-THIRD OF ALL OF THE UNITS IN A DEVELOPMENT MAY RECEIVE MODERATE INCOME HOUSING UNIT ALLOCATIONS;
- (IV) NO MORE THAN 50 MODERATE INCOME HOUSING UNIT ALLOCATIONS PER YEAR MAY BE GRANTED FOR A GIVEN PROJECT;
- (V) MODERATE INCOME HOUSING UNIT ALLOCATIONS MAY BE USED FOR MARKET RATE HOUSING UNITS IF:
 - A. THE DEVELOPMENT IS A MULTI-YEAR PHASED PROJECT; AND
 - B. IN EACH PHASE OF CONSTRUCTION, THE PERCENTAGE OF MODERATE INCOME HOUSING UNITS IS NO LESS THAN THAT REQUIRED BY THE ZONING REGULATIONS; AND
- (VI) THE SUBDIVISION OR SITE DEVELOPMENT PLAN, INCLUDING THE MODERATE INCOME HOUSING UNITS, IS SUBJECT TO THE TESTS FOR ADEQUATE ROAD FACILITIES AND ADEQUATE PUBLIC SCHOOL FACILITIES AS PROVIDED IN SECTIONS 16.1101 AND 16.1103 OF THIS CODE.".

On pages 3 and 4, strike lines 24 through 31 and 1 through 17 respectively.

On page 4, in line 19, strike "3" and substitute "2".

The Chairperson moved to adopt Amendment No. 4 to Council Bill No. 62-2008 as follows: (*This amendment would permit projects that have received building tentative housing allocations prior to the enactment of this legislation to be grandfathered*).

On page 4, immediately following line 18, insert the following:

"Section 3. Be it further enacted by the County Council of Howard County, Maryland, that any moderate income housing unit allocations tentatively granted as of December 1, 2008 shall remain moderate income housing unit allocations pursuant to Section 16.1102(b)(6)of the Howard County Code as it existed on December 1, 2008, except the square footage of any unit may exceed the square footages set forth in Section 16.1102(b)(6)(ii), and any development for which moderate income housing unit allocations have been tentatively granted on or before December 1, 2008 for allocation years 2010 and beyond may use moderate income housing unit allocations for market rate units in those years."

On the same page, in line 19, strike the "3" and substitute "4".

The motion was seconded by Ms. Terrasa.

The roll call vote called by the Chairperson on Amendment No. 4 was: Yea: Council Members Sigaty, Ball, Fox and Terrasa; Nay: Council Member Watson.

Amendment No. 4 to Council Bill No. 62-2008 passed.

Council Bill No. 62-2008 passed as amended.

General

Council Bill No. 1-2009 – Introduced by The Chairperson at the request of the County Executive/Co-sponsored by Calvin Ball, Greg Fox, Mary Kay Sigaty, and Jennifer Terrasa - Prohibiting the discharge of a gun within a certain distance from certain structures under certain conditions; prohibiting the discharge of a gun in the direction of certain structures; providing for certain exceptions; making certain technical corrections; defining certain terms; and generally related to firearm control provisions in the Howard County Code

The Chairperson moved to adopt Council Bill No. 1-2009. The motion was seconded by Ms Terrasa

The Chairperson moved to adopt Amendment No. 1 to Council Bill No. 1-2009 as follows: (This amendment would add a definition of "facility," would strike the requirement that hunting occur on not less than 10 acres outside the Metropolitan District, would strike references to a 300 yard safety zone, would add conditions to shooting in a safety zone; would remove references to maximum range, and would provide that firing a projectile that damages certain personal property or facilities is subject to a civil penalty.)

On page 1, after line 19, insert:

- "(D) (1) "FACILITY" MEANS A BUILDING, STRUCTURE, OR CAMP DESIGNED FOR OCCUPANCY OR USE BY HUMAN BEINGS.
- (2) "FACILITY" INCLUDES A DWELLING, HOUSE, AND RESIDENCE." and renumber the rest of the subsections.

On page 2, strike beginning with "dwelling" in line 6 down through "beings" in line 7 and substitute "FACILITY".

On page 4, in line 5, strike "ON NOT LESS THAN 10 ACRES".

Also on page 4, strike lines 21 through 31 in their entirety and substitute:

- "(C) (1) (I) THE SAFETY ZONE IS THE AREA CONSISTING OF 150 YARDS AROUND A FACILITY. (II) WITHOUT WRITTEN PERMISSION OF THE PROPERTY OWNER, A PERSON SHALL NOT DISCHARGE A GUN WITHIN, FROM, ONTO, OR ACROSS A SAFETY ZONE.
- (2) WHENEVER A PERSON DISCHARGES A GUN, THE PERSON SHALL BE SURE THAT THE DISCHARGE IS TOWARDS A SAFE BACKSTOP OR BACKGROUND OR SHALL USE A SHOTGUN THAT CONTAINS ONLY SHOT.
- IN ADDITION TO ANY OTHER PENALTY PROVIDED BY LAW, A PERSON HAS COMMITTED A (D) CLASS A OFFENSE UNDER TITLE 24, SUBTITLE 1 OF THE HOWARD COUNTY CODE IF THE PERSON DISCHARGES A GUN AND A PROJECTILE FROM THE GUN DAMAGES A FACILITY OR PERSONAL PROPERTY, INCLUDING PETS AND LIVESTOCK, REGARDLESS OF WHETHER THE PERSON HAS COMPLIED WITH ALL OTHER PROVISIONS OF THIS SECTION."

The motion was seconded by Ms. Terrasa.

Council Member Terrasa moved to adopt Amendment No. 1 to Amendment No. 1 to Council Bill No. 1 as follows: (This amendment would restore a 300 yard safety zone.)

In the second line of the descriptive heading, strike beginning with ", would" through "zone".

In 13, strike "150" and substitute "300".

The motion was seconded by Ms. Watson.

The roll call vote called by the Chairperson on the motion was: Nay: Council Members Sigaty, Ball, Fox and Watson; Yea: Council Member Terrasa.

Amendment No. 1 to Amendment No. 1 to Council Bill No. 1-2009 failed.

The Chairperson moved to adopt Amendment No. 2 to Amendment No. 1 to Council Bill No. 1-2009 as follows: (*This amendment would add conditions to the 150 yard safety zone.*)

In line 17, after "SHALL" insert ":

(I) ENSURE THAT THE PROJECTILE HAS A DOWNWARD TRAJECTORY; (II)".

In line 18, after "SAFE" insert ", VISIBLE".

Also in line 18, strike "OR BACKGROUND OR SHALL" and substitute "; OR (IV)".

The motion was seconded by Mr. Fox.

The roll call vote called by the Chairperson on the motion was: Yea: Council Members Sigaty, Ball, Fox and Terrasa; Nay: Council Member Watson.

Amendment No. 2 to Amendment No. 1 to Council Bill No. 1-2009 passed.

The Chairperson moved to adopt Amendment No. 3 to Amendment No. 1 to Council Bill No. 1-2009 as follows: (This amendment would clarify that certain play and athletic areas are included in the definition of "facility".)

In line 4, strike "AND" and after "<u>RESIDENCE</u>" insert "<u>,PLAYGROUND, PLAY STRUCTURE</u>, ATHLETIC FIELD, AND ATHLETIC COURT".

The motion was seconded by Ms. Terrasa.

The roll call vote called by the Chairperson on the motion was: Nay: Council Members Ball, Fox, and Watson; Yea: Council Members Sigaty and Terrasa.

Amendment No. 3 to Amendment No. 1 to Council Bill No. 1-2009 failed.

Council Member Terrasa moved to determine that Amendment No. 1 to Council Bill No. 1-2009 as amended by Amendment No. 2 to Amendment No. 1 is substantive. The motion was seconded by Ms. Watson.

The roll call vote called by the Chairperson on the motion was: Nay: Council Members Sigaty, Ball, Fox, and Watson; Yea: Council Member Terrasa.

The motion failed.

The roll call vote called by the Chairperson on Amendment No. 1 to Council Bill No. 1-2009 as amended was: Yea: Council Members Sigaty, Ball, Fox, and Watson; Nay: Council Member Terrasa.

Amendment No. 1 to Council Bill No. 1-2009 passed as amended.

The Chairperson moved to adopt Amendment No. 2 to Council Bill No. 1-2009 as follows: (This amendment would require certain notifications that hunting may occur.)

On page 4, after line 28, insert:

- "(D) ANNUALLY, AT LEAST 15 DAYS BEFORE ANY GUN IS DISCHARGED ON PROPERTY COVERED BY THIS SECTION, THE PROPERTY OWNER SHALL:
 - (1) SEND WRITTEN NOTICE TO THE CHIEF OF POLICE THAT STATES WHEN HUNTING WILL OCCUR;
 - (2) NOTIFY BY FIRST CLASS MAIL EACH RESIDENT OF ABUTTING PROPERTIES THAT STATES WHEN HUNTING MAY OCCUR; AND
 - (3) POST, AT THE MAIN ENTRANCE TO THE PROPERTY, A SIGN THAT:
 - (I) INDICATES THE RANGE OF DATES WHEN HUNTING MAY OCCUR; AND
 - (II) IS OF THE SAME SIZE AND STYLE AS THE SIGNS THAT THE DEPARTMENT OF RECREATION AND PARKS POSTS FOR MANAGED HUNTS."

Also on page 4, In line 29, strike "D" and substitute "(E)".

The motion was seconded by Ms. Terrasa.

Council Member Watson moved to adopt Amendment No. 1 to Amendment No. 2 to Council Bill No. 1-2009 as follows: (This amendment would require the County Executive to adopt regulations to require certain notifications.)

In line 2, after "D", strike beginning with "ANNUALLY" down through "HUNTS" in line 11 and substitute "THE COUNTY EXECUTIVE SHALL ADOPT REGULATIONS REQUIRING THAT A PROPERTY OWNER GIVE NOTICE BEFORE A GUN IS DISCHARGED ON PROPERTY COVERED BY THIS SECTION".

The motion was seconded by Ms. Terrasa.

The roll call vote called by the Chairperson on the motion was: Nay: Council Members Ball, Fox and Sigaty; Yea: Council Members Terrasa and Watson.

Amendment No. 1 to Amendment No. 2 to Council Bill No. 1-2009 failed.

The Chairperson moved to determine that Amendment No. 2 to Council Bill No. 1-2009 is substantive. The motion was seconded by Ms. Terrasa.

The first roll call vote called by the Chairperson on the motion was: Pass: Council Members Ball, Fox and Watson; Yea: Council Members Sigaty and Terrasa.

The second roll call vote called by the Chairperson on the motion was: Yea: Council Members Sigaty, Ball, Fox and Terrasa; Nay: Council Member Watson.

The motion to determine that Amendment No. 2 to Council Bill No. 1-2009 is substantive passed.
