Council Bill 29-2016 – AN ACT for the purpose of authorizing and empowering Howard County, Maryland to borrow money in the principal amount of up to \$125,103,033 on its full faith and credit, and issue and sell its bonds or other obligations therefor, to be used to pay costs of certain County capital projects (including bridge projects, general county projects, storm drainage projects, school system projects, fire and rescue projects, road resurfacing projects, road construction projects, roadside and sidewalk projects, library projects, community college projects, parks and recreation projects, police projects, sewer projects and traffic improvements projects), which are specified and described in the County's 2017 Capital Budget (including, without limitation, borrowings for certain capital projects previously authorized in other calendar years, which such authorization has lapsed or will lapse), and to pay costs of issuance of such bonds or other obligations; authorizing the County to issue bond anticipation notes or to enter into installment purchase agreements for payment of portions of such costs; and to levy taxes upon the assessable property within the County sufficient, together with other available funds, to pay the debt service on such obligations; and providing for and determining various matters in connection therewith.

Council Bill 30-2016 – AN ACT for the purpose of authorizing and empowering Howard County, Maryland to borrow money in the principal amount of up to \$45,918,993 on its full faith and credit, and issue and sell its bonds or other obligations therefor, to be used to pay costs of certain County water and sewer capital projects which are specified and described in the County's 2017 Capital Budget (including, without limitation, borrowings for certain water and sewer capital projects previously authorized in prior calendar years which such authorization has lapsed or will lapse), and to pay costs of issuance of such bonds or other obligations; authorizing the County to issue bond anticipation notes or to enter into installment purchase agreements for payment of portions of such costs; and to levy taxes upon the assessable property within the County sufficient, together with benefit assessments, ad valorem taxes levied upon the assessable property in the Metropolitan District and other available funds, to pay the debt service on such obligations; and providing for and determining various matters in connection therewith.

Council Bill 31-2016 – AN ACT for the purpose of authorizing and empowering Howard County, Maryland to borrow money in a principal amount of up to \$32,346,180 on its full faith and credit, and issue and sell its bonds or other obligations therefor, to be used to pay costs of certain County road construction projects which are specified and described in the County's 2017 Capital Budget (including, without limitation, borrowings for certain of such capital projects previously authorized), and to pay costs of issuance of such bonds or other obligations; authorizing and empowering the County to issue bond anticipation notes or to enter into installment purchase agreements for payment of portions of such costs; and to levy taxes upon the assessable property within the County sufficient, together with building excise taxes and other available funds, to pay the debt service on such obligations; and providing for and determining various matters in connection therewith.

Council Bill 32-2016 – AN ACT for the purpose of authorizing and empowering Howard County, Maryland to borrow money in the aggregate principal amount of up to \$2,000,000, on its full faith and credit, and issue and sell its bonds or other obligations therefor, to be used to pay costs of certain County education capital projects as more particularly described in the County's 2017 Capital Budget, and to pay costs of issuance of such bonds or other obligations; authorizing and empowering the County to issue bond anticipation notes or to enter into installment purchase agreements for payment of portions of such costs; and to levy taxes upon the assessable property within the County sufficient, together with school facility surcharges and other available funds, to pay the debt service on such obligations; and providing for and determining various matters in connection therewith.

Council Bill 33-2016 – AN ACT pursuant to Section 612 of the Howard County Charter, approving the execution by Howard County, Maryland of one or more capital equipment lease agreements in the aggregate maximum amount of \$11,400,000 to finance the acquisition of equipment and any related costs.

Council Bill 2-2016 (ZRA 156) – Introduced by the Chairperson at the request of ATAPCO Howard Square I Business Trust; AN ACT amending the Howard County Zoning Regulations' CAC (Corridor Activity Center) Zoning District to allow for the reduction of the commercial space requirement in residential developments, if determined appropriate by the Department of Planning and Zoning; and generally relating to CAC developments.

The County Executive has returned Council Bill 2-2016, concerning changes to the Zoning Regulations for the CAC (Corridor Activity Center) Zoning District, with the following veto message:

Dear Dr. Ball:

*Today, by the authority granted by Section 209 of the Howard County Charter, I have vetoed Council Bill No. 2-2016 (CB 2). I do acknowledge that there are valid concerns about the viability of the Corridor Activity Center (CAC) zoning district, but I do not believe that we have had adequate time to properly analyze CB 2, as amended, to determine if this is the best way to address issues with the CAC.*

*On April 4, 2016 an amendment (Amendment No. 1) to CB 2 was introduced and approved by the County Council, which constituted a significant change to the initial Bill. While CB 2 was vetted through a public process. Amendment No. 1 was not provided to the Department of Planning and Zoning (DPZ) with sufficient time in advance to evaluate potential impacts or unintended consequences of the revised proposal; Amendment No. 1 was never discussed or vetted at a public work session and the public has not had an opportunity to provide input on the significant changes to the original Bill.*

*CB 2 was introduced by the Council on January 4, 2016 and a public hearing was held on January 19, 2016. Testimony was offered at the public hearing in opposition to the Bill. On February 1, 2016 the Bill was tabled. The Bill was initially included on the Council work session agenda for March 1, 2016. A revised agenda was issued for the March 1, 2016 work session that removed the Bill from the list of items for discussion. CB 2 was not on the agenda for the work session on March 28, 2016. Despite the public opposition, the Bill and any proposed amendments were not discussed at any Council work sessions. On March 31, 2016, Amendment No. 1 was filed, which significantly altered the Bill introduced at the January 4, 2016 legislative session.*

*The Council approved Amendment No. 1 at the April 4, 2016 legislative session by a vote of 3-2. During the legislative session, Councilmembers expressed concerns regarding the impact and effect of the Amendment.*

*CB 2 was not amended with the benefit of recommendations of the DPZ or the Planning Board. Further, the Amendment approved at the April 4, 2016 legislative session differs significantly from that originally proposed by the Petitioner and reviewed by the DPZ and the Howard County Planning Board.*

*Changes made to the Bill by Amendment No. 1 are, in my opinion based on my experience as a former Councilmember, significant and substantive. First, Amendment No. 1 exempts moderate income housing from the commercial development requirements in the CAC Zoning District.*

*The subject of moderate-income housing units was never reviewed or discussed by the DPZ or the Planning Board. Second, while the Planning Board discussed the option of allowing a fee payment in-lieu of commercial development, the discussions focused on the appropriate amount of commercial space that could be "bought down" and the amount of the buy-down. Amendment No. 1 extends beyond those matters and stipulates the timing of such payments and includes specific criteria by which the fee can be reduced. DPZ did not have an adequate opportunity to review these criteria for clarity and enforceability. Likewise, the DPZ has not assessed the timing of the in-lieu fee payment, based on the operational needs of the various departments involved in fee collection.*

*Finally, Amendment No. 1 precludes developments that exercise the in-lieu fee payment option from receiving any additional residential density. This provision has not been tested by staff to evaluate potential impacts to the CAC Zoning District.*

*Given the significant changes made by Amendment No. 1, the prudent course of action would be to restart the ZRA process. This course of action will allow the Planning Board to review the proposed amendments in a public forum and provide a recommendation based on technical advice from staff and testimony from the public.*

The Council vote to override the County Executive's veto on Council Bill 2-2016 passed.
